

ORDINANCE NO. 720

AN ORDINANCE OF THE TOWN OF NACHES, WASHINGTON, FURTHER AMENDING CHAPTER 8.12.230 A THROUGH C OF THE NACHES MUNICIPAL CODE PERTAINING TO GARBAGE SERVICE RATES

WHEREAS, the Town of Naches approved by Ordinance No. 715 on November 14, 2016, a garbage rate increase for 2017 based upon representations from Yakima Waste Systems, Inc. that the Board of Yakima County Commissioners had raised fees at the Yakima County Landfill and Transfer Station by \$4.00 per ton.

WHEREAS, on November 18, 2016 the Town was provided with a copy of the Board of Yakima County Commissioners Resolution 372-2016 dated November 15, 2016 wherein it was resolved by the Board of County Commissioners of Yakima County, Washington, to approve a lower, \$2.00 per ton rate increase for 2017, effective February 1, 2017; and,

WHEREAS, the Town wishes to conform its rate increase to the rate increase actually approved by the Yakima County Commissioner's and in so doing Schedules A through C of Naches Municipal Code Chapter 8.12.230 need to be changed from the Schedules approved pursuant to Ordinance No. 715; and,

WHEREAS, in all other respects the recitals of Ordinance No. 715 regarding the costs of administration and billings for garbage services and the Town's fiscal responsibilities are true and accurate; and,

WHEREAS, the Town Council determined at the December 12, 2016 meeting that it was in the best interests of the citizens of the Town of Naches to amend its rates in conformity with those set by the Board of Yakima County Commissioner; and,

WHEREAS, the Town Council now wishes to further amend Chapter 8.12.230 by changing the rates established pursuant to Ordinance No. 715 with new rates based upon the Board of Yakima County Commissioners Resolution 372-2016, effective February 2017;

Now, Therefore,

The Town Council of the Town of Naches, Washington, does ordain as follows:

1. The Town Council amends the garbage rate services by amending the Naches Municipal Code as follows:

Chapter 8.12.230 A through C of the Naches Municipal Code is amended to read as follows:

A. Residential Service:	Per Month
96 gallon cart	12.45
64 gallon cart	11.65
48 gallon cart	10.89
48 gallon cart senior discount	8.93
Extra Unit of Garbage	2.04 per bag
96 gallon yard waste container	6.96

Commercial and Industrial:

96 gallon cart	32.29
64 gallon cart	21.53
Extra Unit of Garbage	2.04 per bag

Commercial Containers:

1 ½ yd 1 X weekly	63.71
1 ½ yd 2 X weekly	104.02
1 ½ yd 3 X weekly	144.34

Any extra garbage for 1½ yard containers shall be billed as follows:

½ yard	3.98
1 yard	7.77
1½ yard	11.57

No Change in rates. The disposal fee is weighed and billed at the landfill, and charged to each haul as a pass through. The drop service rates are as follows:

Box Drop Service:

20 yard permanent per haul, plus disposal fees	100.68
20 yard monthly rental	44.86

30 yard permanent per haul, plus disposal fees	117.40
30 yard monthly rental	47.62


(Note: All drop boxes must be emptied a minimum of twice per month)

B. The applicable taxes that shall be charged to the above rates shall include sales tax, the state of Washington Refuse Collection Tax and the Town's current utility tax rate.

C. The rates shown above include a 10% administration fee of the contract and billing, charged starting in 2017.

2. The rates in this Section shall be effective beginning February 2017 billing period.


