A RESOLUTION OF THE TOWN OF NACHES, WASHINGTON,  
AUTHORIZING THE MAYOR TO SIGN THE CONTRACT  
MODIFICATION FOR LIBRARY SERVICES ADDENDUM A  
REGARDING THE FISCAL YEAR 2018.

WHEREAS, the Town of Naches currently contracts with the Yakima Valley Libraries for library services in the Town of Naches; and,

WHEREAS, the Town of Naches provides the library a building pursuant to a contract; and,

WHEREAS, the library utilizes utilities provided by the Town of Naches and is required to pay for those utilities; and,

WHEREAS, the Town Council of the Town of Naches finds that it is in the best interests of the residents of the Town modify the contract to require payment of utilities by the Yakima Valley Libraries;

Now, therefore,

BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF NACHES,  
WASHINGTON, AS FOLLOWS:

The Town Council of the Town of Naches hereby authorizes the Mayor to sign the Contract Modification for Library Services, Addendum A, which requires payment to the Town for utilities at the library building up to \$3,600.00 in the year 2018, a copy of which is attached hereto as Exhibit "1."





As per our contract for library services, the amount estimated for the 2018 fiscal year will not exceed \$14,450.79. We will have the actual amounts later this year and will mail an invoice to you early in 2018, so please do not pay from this letter. I have attached the addendum as we have in the past.

I thought you might enjoy a few statistics about patron use of the Naches Community Library. In 2016 the library was open 1,300 hours, received over 11,815 visitors, scheduled 1014 computer appointments, and circulated 14,674 items to your community. Yakima Valley Libraries provides two part-time public service staff who serve the local community at the Naches Library.



## ADDENDUM A

### CONTRACT MODIFICATION FOR LIBRARY SERVICES Between the Town of Naches And Yakima Valley Libraries

In recognition of the services provided to library patrons that are outside the boundaries of the Town of Naches and the space allocated by the Town of Naches for a library building, Yakima Valley Libraries agrees to reimburse the Town of Naches for actual utilities to support the library building with a cap not to exceed \$3,600 annually unless mutually agreed upon in writing. The Town will submit actual documentation quarterly for reimbursement.

This agreement will cover fiscal year 2018. This Addendum will be reviewed on an annual basis no less than 60 days prior to the start of the new year.
