

RESOLUTION NO. 2017-4

**A RESOLUTION OF THE TOWN OF NACHES, WASHINGTON
APPROVING AND ADOPTING THE TOWN OF NACHES 2017
COMPREHENSIVE PLAN UPDATE PURSUATN TO THE GROWTH
MANAGEMENT ACT.**

WHEREAS, the Growth Management Act, adopted by the Washington State Legislature in March, 1990 (ESHB 2929) established a framework for Comprehensive Planning statewide, requiring higher growth areas, including Yakima County and cities within Yakima County, to comply with certain growth planning directions; and,

WHEREAS, the Growth Management Act sets forth required elements for a Comprehensive Plan, including a land use element, Capital facilities element, transportation element, housing element, utilities element, and any other element deemed appropriate to describe adequate provisions for additional needs of future populations and growth; and,

WHEREAS, the Town of Naches has facilitated and held Public Hearings on March 6 and March 13, 2017 as required by law, both before the Naches Planning Commission and the Naches Town Council; and,

WHEREAS, the Naches Town Council has received and considered all public testimony and evidence submitted at public hearings; and,

WHEREAS, the Naches Town Council has received comments from applicable state agencies and responding entities concerning the proposed Comprehensive Plan Update, and has duly considered such comments within such plan; and,

WHEREAS, the Naches Town Council finding and determining that at least sixty (60) days has elapsed from the date the Comprehensive Plan Update was submitted to Washington State Department of Commerce for review and comment; and,

WHEREAS, the Naches Town Council finds and determines that the Comprehensive Plan Update satisfies the requirements of the Growth Management Act, and adoption thereof is in the best interest of residents of the Town of Naches and those persons residing in the proposed and designated urban growth area boundary.

**BE IT RESOLVED FOR THE TOWN COUNCIL FOR THE TOWN OF
NACHES, WASHINGTON, AS FOLLOWS:**

1. That the Comprehensive Plan Update, in its final form dated March 13, 2017, which Comprehensive Plan Update is incorporated herein by this reference, is hereby approved; and the Mayor is hereby authorized to execute this Resolution and any

other appropriate documentation required for approval and submission of the Comprehensive Plan, for and on behalf of the Town Council of the Town of Naches.

2. This Resolution shall be effective immediately upon passage and signatures hereto.


