PASSED BY THE TOWN COUNCIL OF THE TOWN OF NACHES, WASHINGTON, this 13th day of January, 2020.





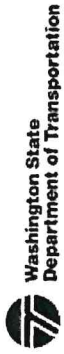

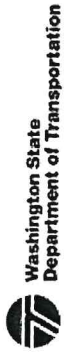
