

ORDINANCE NO. 764

**AN ORDINANCE OF THE TOWN OF NACHES, WASHINGTON, AMENDING
CHAPTER 8.12.230 A THROUGH C OF THE NACHES MUNICIPAL CODE
PERTAINING TO GARBAGE SERVICE RATES**

WHEREAS, the Town of Naches previously approved a garbage contract agreement with Yakima Waste Systems, Inc.; and,

WHEREAS, the garbage rate increase includes the Consumer Price Index (CPI). The Town of Naches received a letter, from Yakima Waste Systems, Inc. which presented the proposed increase to the Town Council; and,

WHEREAS, the ordinances includes a 10% charge added to the bills for administration and billing costs; and,

WHEREAS, there is a cost to administering the contract and the billings for garbage services that the Town must charge the users to be fiscally responsible; and,

WHEREAS, the Town Council determined at the October 11, 2021 meeting that it was in the best interests of the citizens of the Town of Naches to increase the garbage service rates, and in fact increased those rates; and,

WHEREAS, the Town Council wishes to now to ratify its determination that garbage service rates should increase for the year 2022, as outlined, and discussed at the October 11, 2021. Town Council meeting;

Now, Therefore,

The Town Council of the Town of Naches, Washington, does ordain as follows:

1. The Town Council decision to increase garbage rate services by amending the Naches Municipal Code as follows:

Chapter 8.12.230 A through C of the Naches Municipal Code is amended to read as follows:

A.	Residential Service:	Per Month
	96 gallon cart	14.42
	64 gallon cart	13.40
	48 gallon cart	12.50
	48 gallon cart senior discount	10.33
	Extra Unit of Garbage	2.32 per bag
	96 gallon yard waste container	7.95
	Commercial and Industrial:	
	96 gallon cart	36.31
	64 gallon cart	24.31
	Extra Unit of Garbage	2.32 per bag

Commercial Containers:

1 ½ yd 1 X weekly	72.80
1 ½ yd 2 X weekly	119.79
1 ½ yd 3 X weekly	166.78

Any extra garbage for 1½ yard containers shall be billed as follows:

½ yard	4.81
1 yard	9.39
1½ yard	14.00

No Change in rates. The disposal fee is weighed and billed at the landfill, and charged to each haul as a pass through. The drop service rates are as follows:

Box Drop Service:

20 yard permanent per haul, plus disposal fees	111.05
20 yard monthly rental	48.48

30 yard permanent per haul, plus disposal fees	129.49
30 yard monthly rental	52.53

(Note: All drop boxes must be emptied a minimum of twice per month)

B. The applicable taxes that shall be charged to the above rates shall include sales tax, the state of Washington Refuse Collection Tax and the Town's current utility tax rate.

C. The rates shown above include an additional 10% for contract administration and billing, for the year 2022.

2. The rates in this Section shall be effective beginning January 2022 billing period.


